ORDER

The erstwhile National Commission for Scheduled Castes and Scheduled Tribes (NCSCST) was bifurcated into two separate Commissions namely, the National Commission for Scheduled Castes (NCSC) and the National Commission for Scheduled Tribes (NCST) w.e.f. 19.2.2004. In pursuance of this bifurcation, the officers and staff of the erstwhile NCSCST is required to be divided between the National Commission for SCs and National Commission for STs. It is accordingly ordered that:-

- (i) The officers and the staff of the erstwhile NCSCST posted at the Head Quarters/Secretariat at New Delhi be bifurcated between the NCSC, and the NCST as shown in the Statement attached as Annex -'A'.
- (ii) The officers and staff of the Joint Cadre posted in the erstwhile NCSCST, Ministry of SJE and Ministry of Tribal Affairs be bifurcated between NCSC and NCST as shown in the Statement attached as Annex-'B'.
- (iii) The officers and staff (other than those belonging to Joint Cadre) posted at Headquarters of the 18 State Offices be bifurcated between NCSC and NCST as shown in the Statement attached as Annex-'C'.
- (iv) 18 State Offices of the erstwhile NCSCST be bifurcated between NCSC and NCST as indicated in the Table below:

 As far as possible, the division of the officers and the staff of the erstwhile NCSCST including those belonging to the Joint Cadre between NCSC and NCST has been - made in the ratio of 2:1 respectively as decided by the Ministry of SJE and the Tribal Affairs.

- 3. The deployment of officers and staff of the erstwhile NCSCST between NCSC and NCST, (as shown in the Statements at Annex-'A' and Annex-'B') as also of the State Offices (as shown in the Statement at Annex-'C') is based, except a few minor modifications, on the lists of bifurcation prepared by the Committee of Joint Secretaries set up by the Ministry of SJE for this purpose.
- 4. Separate orders will be issued by both the Commissions in respect of the organizational structures of NCSC and NCST at the Headquarters/Secretariat (after bifurcation of officers and staff between the two Commissions as indicated in the Statements at Annexes 'A' & 'B') and deployment of officers and staff in the 12 State Offices under NCSC and 6 State Offices under NCST [as indicated in para 1 (iv)] also showing their jurisdiction.
- 5. The existing Cash Section having both the staff of NCSC and NCST will continue to work for preparing salary bills, TA bills and other bills as is being done now. Similarly, in the absence of a separate room, the existing system of procurement and distribution of stationery items will continue till shifting of NCST to the 6th Floor. The work in relation to compilation etc. of the Annual Report will be handled by the Economic & Social Development Wing/Unit of the respective Commission and the work relating to the printing of the material therefor in both the Commissions will be done by their respective Administration and Coordination Units.
- 6. The NCST has already initiated the exercise of setting up a new Office for it on the 6th floor of Lok Nayak Bhawan and till such time the new office for NCST is ready, its officers and staff will continue to sit at/on their existing work stations/rooms until further orders.
- This Order, which issues with the approval of Secretary, NCSC and Secretary, NCST, comes into force with immediate effect.
