The PCR Cell Unit is registering and investigating cases under the PCR Act, 1955 and the SC/ST(PoA) Act, 1989. In addition to the investigation and prosecution of Criminal cases under these Acts, the officers of the cell are also making enquires on the related complaints and also indulge in the collection of intelligence about the atrocities, ill-treatment and practice of the "untouchability" and other relevant social evils.
